PRE-QUALIFICATION REQUIREMENTS

- (i) Certificate of Incorporation with Corporate Affairs Commission (CAC)
- (ii) Evidence of Current Tax Clearance for three years (2013, 2014 and 2015), with Tax Identification Number (TIN) clearly visible
- (iii) Current Certificate of Registration with Kaduna State Tenders Board
- (iv) Current Registration of Business premises with Kaduna State Ministry of Commerce
- (v) A valid Pharmacists Council of Nigeria (PCN) Registration of Premises or evidence of current registration for the year 2016, except for Lots 5, 6 and 10.
- (vi) A valid Pharmacist License to Practice or evidence of current registration for the year 2016, except for Lots 5, 6 and 10.

- (vii) Evidence of Company's Audited Account for the last three (3) years (2013, 2014 and 2015)
- (viii) VAT Registration and Evidence of past VAT remittance at least in the three years (2013, 2014 and 2015)
- (ix) Evidence of Financial Capability and Banking Support
- (x) Company profile, including official contact addresses, phone numbers, e-mail addresses, and list of key technical personnel with their qualifications/ experience
- (xi) Evidence of other similar verifiable projects successfully executed/completed within the last three (3) years (2013, 2014 and 2015)
- (xii) Any other relevant information that would be helpful in determining the firm's suitability for the works
- (xiii) Certified Bank Draft of N50,000.00 payable to the Kaduna State Government for each lot. Submissions not accompanied with the Certified Bank Draft of N50,000.00 draft shall not be considered.

Pre-qualification submission must be made in Six (6) copies (One original and five copies) in a sealed envelope clearly marked with the name of the lot for which application is made.
