- Evidence of current Industrial Training Fund (ITF) compliance certificate.
- Evidence of compliance with National Social Insurance Trust Fund (NSITF).
- Evidence of registration on the National Database of Contractors, Consultants and service providers by BPP or a copy of Interim Registration (IRR) as evidence of compliance with the requirement.
- Sworn Affidavit disclosing whether or not any officer of the relevant committees of the Ebonyi State College of Education. Ikwo or the Bureau of Public Procurement is a former or present Director, shareholder or has any pecuniary interest in the bidder and toconfilm that all information presented in its bid are true and correct in all particulars.
- Audited Accounts for the last three (3) years 2015, 2016, 2017.
- Verifiable documentary evidence of at least three (3) similar jobs including Letter of Awards. Valuation Certificates and Job completion Certificates in the last five (5) years.
- The list of Plants/Equipment with proof of Ownership. Lease (where applicable).
- Minimum turnover of not less than N50,000,000.00 for the projects (where applicable), which should be in line with the formula specified in the Standard

- Bidding Document (SBD) for works published by the Bureau of Public Procurement.
- Company Profile including Curriculum Vitae of Key Staff with their copies of professional qualifications.
- Evidence of Interim Registration Report from Bureau for Public Procurement (BPP).
  - Sworn affidavit confirming that none of the firm directors have been convicted of criminal offence in any court of law and that all information presented in the Company bid are true and correct.
- Evidence of payment of non-refundable tender fee of N10,000.00.
- Company bank statement for the last 12months and bank reference from a Nigerian bank.
- Any Company that is interested in Lot 1 or 2 shall state period of completion, evidence of such job done elsewhere, equipments, number of staff and their qualifications that shall be used/deployed for the job.
