The attention of all interested bidders is drawn to the following modifications that supersede the requirements published earlier on Monday October 16th, 2017 for compliance.

- (1) Item 2.0(e) shall be: 'Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate (2017)'.
- (2) Item 2.0(f) shall be: 'Evidence of Registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 1st January, 2018 or valid Certificate issued by the BPP'.
- (3) Item 3.0(a): 'Evidence of VAT registration and remittances' is not required.
- (4) The non-refundable Tender processing fee shall be N10,000.00 for each Lot instead of N20,000.00. Bidders that paid N20,000.00 shall be refunded the balance.
- (5) Interested companies for LOT 1 (Construction of Road and Drainage) should have a minimum turnover of N25,000,000.00 in years 2014-2016. (Mandatory Requirement).
- (6) The new closing date and time shall be **18th December 2017 at 12:00 noon** instead of 27th November, 2017 published earlier.

1.0 INTRODUCTION

2.0 MANDATORY PRE-QUALIFICATION REQUIREMENTS (WITHOUT SCORE)

- (a) Evidence of incorporation/registration with Corporate Affairs Commission (CAC) with Forms C02 and C07 containing list of Directors and Shareholders.
- (b) Company Tax Clearance Certificate for year 2014, 2015 and 2016.
- (c) Pension Certificate of Compliance from PEN COM, valid till December, 2017.
- (d) Industrial Training Fund (ITF) Clearance Certificate valid till December, 2017.
- (e) Evidence of registration and remittance to National Social Insurance Trust Fund (NSITF)
- (f) Evidence of registration with Bureau of Public Procurement (BPP) database.

(g) Sworn Affidavit that none of the Directors of the firm has been convicted in any country for any criminal offences relating to fraud or financial impropriety and that the company is not bankrupt or under receivership.

(h) Sworn affidavit disclosing whether or not any officer of the Polytechnic or BPP, is a former or present Director, Shareholder or has any pecuniary interest in the company.

(i) A written and signed attestation by a director of a company that the company shall not sublet the contract without written approval from the claimant; shall employ and maintain the registered engineer (s) claimed during the project execution (LOT 1); shall deploy the equipment claimed in the project execution.

3.0 OTHER PRE-QUALIFICATION REQUIREMENTS (WITH SCORE)

(a) Evidence of VAT registration and remittances.

(b) Company Audited Account for year 2014, 2015 and 2016.

(c) Letter of company reference from a reputable registered commercial bank with account name and number.

(d) Evidence of Social/Community Responsibility.

(e) Company profile indicating full location address, contact number(s), e-mail address; curriculum vitae of key staff with academic and professional certificates, list of relevant equipment, list of verifiable and completed/on-going projects within year 2013 to 2017 with evidence of award and completion/execution in that order.

4.0 COLLECTION OF TENDER DOCUMENTS

Tender documents can be collected at Room 25, Central Administrative Building after paying a non-refundable tender processing fee of N 20,000.00 for each of the projects at the cash office of the Bursary department.

5.0 SUBMISSION AND OPENING OF DOCUMENTS

- (b) Tender documents are to be similarly treated and the contact phone numbers, e-mail address of the contractor is to be written at the back of this envelope.
- (c) Both envelopes are to be sealed in a bigger envelope with the targeted Lot number and titled written at the top right corner and addressed to the 'Registrar, Federal Polytechnic Bauchi' for submission **not later than 12:00 noon 27th November, 2017.**
- (d) Pre-qualification bids would be opened on 27th November, 2017 by 12:15pm at the Council Chamber of the Polytechnic.
- (e) Tender bids of pre-qualified contractors shall be opened at a later date after notification.
- (f) All interested contractors and other stakeholders are invited to attend.
