- (10) Copy of BPP's interim Registration Report – IRR (expiring 31st December, 2017)
- (11) Evidence of payment of Tender Fee indicating the chosen lot;
- (12) Evidence of up-to-date registration of company with relevant professional bodies (for training services: and
- (13) Verifiable and documented evidence of award and successful completion of, at least, two (2) similar contracts within the last five (5) years stating the scope, value, location and referral contact and telephone number.
- (14) List of equipment to be used for the projects stating whether owned, to be hired or leased with evidence of ownership or hire for construction works.
- (15) Company's registered address, functional address, GSM phone number and email address.
- (16) Company's banking detail, including Account Name, Account Number, Bank Name, Branch and Sort Code.
- (17) Packaging/presentation of technical bid should be in the exact order they are listed out under these eligibility and capability criteria.

(6.0) SUBMISSION OF BIDS

(i) Interested Contractors and suppliers shall submit one copy of their Technical bids and completed financial bids. The Technical Bid and Financial Bid per Lot shall be placed in two different sealed envelopes and each appropriately labelled "Technical Bid" and "Financial Bid" as well as the "Project Name/Title" and "Lot No" on the same side of the envelope. The reverse side of each of these two envelopes containing separately Technical and Financial Bids should be enclosed in a third outer envelope which should be sealed and labelled "Technical and Financial Bid" with the "Project Name/Title" and "Lot No" clearly written on the top Right Hand corner.

(7.0) OPENING OF BIDS

(i) Opening of Technical bids for the Supply of Goods and Works will commence at **2.00pm on Wednesday 26th July, 2017** in the Administrative Conference Room, Federal College of Agriculture, Akure

(ii) Financial bids of those who are successful in the technical bid evaluation will be opened at a date to be communicated to them. All bidding companies and/or their representatives, relevant professional bodies, Non-Governmental Organisations (NGOs), representatives of BPP and interested members of the public are hereby invited to witness the opening of the technical bids on the dates and times mentioned above.

(8.0) BIDS EVALUATION AND AWARD

Immediately after the opening of the technical bids, all submissions will be assessed for eligibility using the non-scoring responsive criteria listed out above.

Eligible Submissions will then be assessed for capability based on the scoring of responsive criteria also listed above. Award of contract will be recommended in favour of the lot evaluated responsive bids.

- (i) Only Technically qualified Bidders shall be invited to the next stage of the procurement process.
- (ii) Original documents of the Eligibility criteria of any Bidder may be requested for sighting.
