(1.0) INTRODUCTION

- (e) Evidence of current Nigeria Social Insurance Trust, Fund (NSITF) Compliance Certificate valid till 31st December, 2019;
- (f) Evidence of Registration on the National Database of Federal Contractors, Consultants and Services Providers by submission of interim Registration Report (IRR) expiring on 30th June, 2019 or valid Certificate issued by BPP;
- (g) Sworn Affidavit disclosing whether or not any officer of the relevant committee of the Federal University Oye-Ekiti or Bureau of Public Procurement is a former or present director, shareholder or has any pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- (h) Company's Audited Accounts for the last three year (3): 2016, 2017 and 2018;
- (i) Evidence of financial, capability to execute the project by submission of Reference Letter from reputable commercial bank indicating willingness to provide credit facility for the execution of the project when needed;
- (j) Company Profile with the Curriculum Vitae of Key Staff to be deployed for the project, including copies of their Academic/Professional qualifications (in case of construction: COREN, QSRBN, ARCON, CORBON etc.);
- (k) Documentary evidence of at least three (3) similar jobs executed in the last three (3) years with Federal Government Ministries, Departments and Agencies including Letter of Awards, Valuation Certificate, job Completion Certificates and Photographs of the project;
- (I) List of Plants/Equipment with proof of Ownership/Lease;
- (m) For joint Ventures/Partnership, Memorandum of Understanding (MOU) should be provided (all the eligibility requirements are compulsory for each JV partner);
- (n) All documents for submission must be transmitted with a Covering/ Forwarding letter under the Company/Firm's Letter Head Paper bearing amongst others, die Registration Number (EC) as issued by the Corporate Affaire Commission (CAC), Contact Address, Telephone Number (preferably GSM No.), and e-mail address. The Letterhead Paper must bear the names and

Nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorised officer of the firm.

(4) SUBMISSION OF BIDS

Prospective bidders are to submit three (3) copies of Pre-qualification Documents (Technical Documents) enveloped and sealed, stating the company name and the Lot on the both side of the envelop and address to: Head Procurement Unit, Office of the Vice Chancellor, Federal University Oye-Ekiti.

Submission of pre-qualification documents closes **Monday**, **17 June**, **2019 by 12 noon**. Any bid submitted after the closing time stands rejected. The submitted technical bids will be opened immediately at the Procurement Unit, Office of the Vice- Chancellor, Central Administrative Building, Main Campus, Federal University Oye-Ekiti. Bidders/Company representatives and interested members of the public, civil society and nongovernmental organisations are hereby invited to witness the public opening.
