- (vi) Company's Audited Account for the last three (3) years (2012, 2013 and 2014).
- (vii) Evidence of registration on the Database of Contractors, Consultants and Service Providers by inclusion of the Interim Registration Report (IRR) issued by BPP in line with the provisions of Section 5(h) of the PPA, 2007.
- (viii) Letter of financial reference from a reputable bank.
- (ix) Verifiable list of technical and professional staff. Enclose photocopies of credentials.
- (x) Verifiable list of executed similar jobs with letters of award and certificates of practical completion.
- (xi) A Sworn Affidavit that all the information/documents provided is correct and verifiable.
