Request for Expression of Interest for the Operations and Management Concession of the Bola Ahmed Tinubu Diagnostic Centre at the Lagos State University Teaching Hospital (LASUTH) Ikeja

1.0 BACKGROUND

Lagos, with a population of over 21 million people and projected to be the 3rd largest megacity in the world within the next decade hitting the 25 million mark, is Nigeria's economic and commercial nerve-centre.

In line with its mandate to protect, promote and restore the health of Lagosians. the Lagos State Government (LASG) seeks to enhance the access of residents to Diagnostic Services by providing specialised Diagnostic Investigations/Interventions.

In tandem with the State Government's drive to leverage on the resources of the private sector as an effective healthcare financing tool to provide qualitative healthcare services, the Lagos State Ministry of Health is desirous of revamping its Diagnostic Centre situated within the LASUTH Complex in GRA through a PPP initiative. Accordingly, the LASG hereby requests for expression of interest from interested international and local parties/consortia to provide comprehensive diagnostic services.

2.0 PROJECT SCOPE

2.1 PPP Model

The envisaged holistic upgrading viz-a-viz re-equipping, as well as operations and management in line with international best practice is to be achieved via an Equip, Operate and Manage Concession. To this end, it is to be noted that Government is seeking the successful implementation of this project with no additional financial investment on its part.

2.2 PROPOSED UPGRADING

The envisaged upgrading encompasses: the provision of requisite equipment relevant for the 24/7. 365-day provision of comprehensive Laboratory/Diagnostic Service, Wellness 'Services' as well as Facilities for Tele-Medicine.

2.3 FACILITIES' MANAGEMENT SERVICES:

Expectedly, the selected service provider would also be responsible for the provision of "hard" and "soft" services through preventive, corrective, predictive, and reliability-centered maintenance and planning programmes to improve operational efficiency, effectiveness of the facility's primary activities, asset life, safety, and compliance with best practice regulatory requirements. The eventual

services will also include Clinical Facility Management Services encompassing biomedical and technical maintenance of all the medical and diagnostic equipment at the centre.

Provide evidence of at least 5 years previous experience / portfolio in carrying out similar projects, including the following details: (i) Name of Project, (ii) Brief description, (iii) Clients & Scope of Work, (iv) Contract value and (v) Name and address of a Referee from client's company

3.3 SAFETY, HEALTH AND ENVIRONMENT (SHE) STATEMENT

Provide SHE Policy and evidence of Management's commitment to the policy.

3.4 QUALITY ASSURANCE AND QUALITY CONTROL (QA/QC)

Provide Quality Assurance and Quality Control Policy and Plan along with ISO Certification (if available).

3.5 FINANCIAL CAPABILITY

Provide the following information: (i) Audited Financial Statements for the years 2013 – 2015 and latest Management Accounts and (ii) Evidence of available financing and/or access to credit line for the project.
