## **(1.0) PREAMBLE**

The Sokoto State University hereby issues the General Procurement Notice to inform the eligible Contractors, suppliers and the General public the University is to undertake the under listed projects using its year 2015/2016 (MERGED) TETFUND intervention.

## **(2.0) SCOPE OF WORK**

LOT 2: Construction of Block of 9 Lecture Halls

LOT 3: Construction of Entrepreneurship Centre

LOT 4: Procurement of Furniture for Faculty of Sciences Block B.

LOT 5: Procurement of Furniture for Block of 9 Lecture Halls

LOT 6: Procurement of 1 No. Toyota Coaster Bus

LOT 7: Furnishing of TETFund 2014 Special Intervention Large Lecture Theatre

LOT 8: Furnishing and procurement of Equipment for Entrepreneurship Centre

LOT 9: Renovation of Twin Lecture Theatre and Single lecture Theatre (Tetfund 2013 Special Intervention)

**(3.0)** Note that the bid documents would be evaluated on responsiveness to criteria including but not limited to:

- (a) Company registration with Corporate Affairs Commission
- (b) Company Tax Clearance Certificate for the last three (3) years (2015, 2016, 2017)
- (c) Evidence of PENCOM Compliance Certificate. Valid till 31/12/18
- (d) Evidence of ITF Compliance Certificate. Valid till 31/12/18

- (e) Evidence of Financial Reporting Council
- (f) Evidence of Registration with NSITF. Valid till 31/12/18
- (g) Current audited accounts of the company for the last three (3) years 2015, 2016 & 2017.
- (h) Evidence of Registration with BPP data registration (IRR) Expiring 31/12/18
- (i) Sworn Affidavit showing that no Director of the company has been convicted in any Country for any criminal offence relating to fraud or financial impropriety.
- (j) Evidence of similar jobs successfully executed
- (k) Evidence of Financial Capability and Banking support to the amount applied for.
- (l) Key personnel experience with technical qualifications
- (m) Evidence of Company's ownership of required plants and equipments for the work.
- (n) Program of work indicating clearly the commencement and completion duration of the Project

Interested and eligible Contractors, suppliers are advised to lookout for the Specific Procurement Notice (SPN) for various projects mentioned above in the National Dailies and the Notice Boards depending on the threshold of each project.
